1.2. General

1.3. Installation

This product must be connected and installed by a qualified electrician who is familiar with the relevant regulations (e.g. VDE).



Never plug the product into voltage / power supply immediately after it has been moved from cold into warm environment (e.g. during / after transport / unboxing). The resultant condensed water may damage the product or may cause electric shock.



Allow the product reach the ambient temperature. Wait until the condensation has evaporated, this can take a few hours. Only then can the product be connected to the voltage / current supply and put into operation.



This product may have screw terminals with open electrical contacts. It is essential to ensure that the connection is made only when no voltage / current is applied. Secure the power supply to prevent accidental reconnection. Verify the absence of voltage using an appropriate meter.



Always connect earth ground to the device at the indicated protective earth terminal (PE or earth symbol indication).

1.4. Operation

Use the product in the specified environment. Use outside of the specifications can damage the product and/or stop any operation. The product may not be exposed to extreme temperatures, direct sunlight or strong vibrations. Protect the product from moisture, dust and dirt.



Operation in environments with excessive dust, flammable gases, vapours or solvents is not permitted. It may cause explosion or fire.

- · Do not overload the product. Note the input / output voltage and currents as well as output powers indicated on the product.
- Depending on the input currents and input voltages, suitable connecting cables with appropriate cable diameter must be used. Only

1.5. Maintenance and Cleaning

- If the product and/or the connecting cable is damaged, do not touch it: there is mortal danger from electric shock! First, turn off the power supply to all poles of the product. Verify the absence of voltage using an appropriate meter.

1.6. Disposing

2 Introduction

The DCF 77 radiosignal, received by the AD 650 radiosignal receiver, enables nearly absolute precision in clock operation and ensures a fully automatic transition to daylight saving time.

The receiver can be connected to all types of MOBATIME master clocks using a two-wire unshielded cable.

3 Technical Data

3.2. Placement of the AD 650

Align the radio signal receiver with the front cover (using screws) or the rear surface pointing towards the DCF Mainflingen transmitter (approximately to the west). If the DCF reception is of good quality, the time base on the connected clocks will synchronize automatically within a few minutes. In the case of poor reception (especially during the day), the initial setup must be performed manually so that the LED blinks regularly.

Like any radio receiver, the DCF radio signal receiver is subject to disruptive and attenuating influences. Their impact increases with the distance from the DCF transmitter in Mainflingen and the presence of the following factors:

- · metal cladding of buildings and rooms, metal structural elements (beams, reinforcement, roofs)
- · strong walls and insulation, basement and cellar spaces
- inappropriate local geographical conditions (difficult to predict in advance)
- atmospheric disturbances, storms
- · unshielded electrical appliances
- · televisions and computers located near the DCF radio receiver

4 Connection

The AD 650 DCF receiver is delivered with a 10 m cable. The maximum length of the cable depends on its cross-section (at least 0.25 mm²) and can be up to 200 m. We recommend using shielded cable only in critical conditions.

The functionality of the receiver is independent of the connection polarity. Cut the cable to the required length.

With good reception, the LED on the receiver flashes once per second with a skip of 1 pulse at the 59 th second.




Do not install the receiver close to buildings consisting of metallic steel structures, near to PCs, TV and radio receivers or in places surrounded with thick walls or into underground or cellar areas.

4.1. Connection to Master Clock

Connect the AD 650 DCF receiver to the master clock terminal board (+DCF- terminal).

4.2. Connection to Digital Clock




For generation 4 digital clock:

It is important to configure DIP switch position to DCF.

Connect the AD 650 DCF receiver to the clock terminal board placed on the anchoring plate (LINE IN terminal).

Wire Color	Connector
White	LINES -
Brown	LINES +






In case of issues with receiving the DCF signal when using the AD 650 / DCF 4500 receiver, it is necessary to ground (connect to PE) one of the signals/inputs (LINES+ or LINES-).

For the ECO-DC clock, it is always necessary to ground one (connect to PE) of the signals/inputs (LINES+ or LINES-).

Wire Color	Connector
White	LINES -
Brown	LINES +
Yellow / Green (PE conductor)	Either LINES + or LINES -



5 Digital Clock Settings

5.1. Generation 4 Digital Clock

- 1. Enter the digital clock menu, navigate to the 5 4 Π Γ submenu and proceed to enter.
- 2. Navigate to item _ / and set it to value A (automatically set timezone).
- 3. Navigate then to item _ 2 and set it to value | R (autodetection).
- 4. Return to digital clock menu, navigate to the 🔞 / 5 P submenu and proceed to enter.
- Navigate to item d ? and set it to value ? (automatically set timezone).

5.2. Generation 3 Digital Clock



Following procedure is for all generation 3 digital clocks except ECO-DC and ECO-M-DC series.

- 1. Enter the digital clock menu.
- 2. Navigate to item P 3 and set it to value R .
- 3. Navigate to item $P \lor q$ and set it to value $R \lor q$.
- 4. Navigate to item P 7 and set it to value R .



Following procedure is only for generation 3 ECO-DC and ECO-M-DC series.

- 1. Enter the digital clock menu.
- 2. Navigate to item P 4 and set it to value R .
- 3. Navigate to item $P \subseteq A$ and set it to value $A \in A$.
